Hiring Short-Term Foreign Business Professionals

You've finally found the right professional for your job! Now you want to get them here and working on the project as soon as possible.

Companies looking to bring American or Mexican business professionals can benefit from the North American Free Trade agreement (NAFTA) which allows for American and Mexican nationals to work in Canada without a Labour Market Impact Assessment (LMIA) and in some instances, a Work Permit.



Business Visitors to Canada are both LMIA and Work

Permit exempt, they must meet specific conditions that show that they will not enter the Canadian Labour Market. A business visitor is someone who comes to Canada to engage in international business activities without directly entering the Canadian labour market. For example, someone who comes to Canada to meet people from companies doing business with his or her country would be a business visitor

Visitors may come to Canada to observe site visits. Alternatively, a Canadian company may have invited them to Canada for training in product use, sales or other functions related to a business transaction.

Business visitors must prove that their main source of income and their main place of business

are outside Canada.

Business Professionals, Intra-company Transferees and Traders/ Investors are exempt from the LMIA requirement, but do require a Work Permit. Often these persons are business professionals, such as accountants or engineers who have been contracted by the Canadian company to do short term contract work for them. Intra-company transferees are high-level professionals who are send to Canada to work short-term for the same employer.

It is important to be aware of these requirements and the difference between a business visitor versus a business professional. Often, we see foreign workers delayed at the border because they have not prepared their business visitor or business professional paperwork before attempting to enter Canada. This often results in a refusal at the border, and a delay in the job in Canada. This can be extremely detrimental in the Manufacturing business, where jobs work on strict timelines, where delays are costly to you as an employer.
